Dear Board of Education Members,

I am asking you to do the right thing, and vote against the hearing officer's recommendation not to renew Universal Daroff Charter School.

In our current environment of racial discrimination, it does not go without notice that predominantly African American populated/run charter schools are the target of non-renewal recommendations. My students, their families, and our school community deserve better. Universal Daroff Charter School has become a community hub - not only for education, but for information, support, food, clothes, household items, safety (e.g. free smoke alarms), celebrations, and a catalyst for positive community relations with the local police precinct, just to name a few important roles it has played for this community. We are striving to make lives better beyond the classroom and to provide support where it was greatly needed.

As a special educator who came in on day one of Universal Companies taking over Samuel L. Daroff, I will not forget opening up the special education files and finding my students' paperwork – legal paperwork – the paperwork used to protect and guide my students' education – in a state of disarray. Two of my coworkers and I spent countless weeks, and stayed well after the school day ended, to go through page by page, of IEPs, evaluation reports, and miscellaneous paperwork in our students' files, in order to account for everyone. Paperwork was either left by teachers who did not know what they were doing, or who left the paperwork in that state out of spite – either way, it showed a lack of respect and concern for the students whose names were on those pages. That's what Universal walked into. Flash forward to a solid, caring, educated, and loving special education department, which has recently received the accolade of having 100% compliance after being audited by the state. Every one of those pages that we meticulously put into place, has been kept in place for nearly 11 years because we care, we do our jobs with pride, and know that everything we do affects our students. Our most recent special education audit by the state yielded accolades to our special education department, when our paperwork was found to be 100% compliant.

Our school focuses on the whole child, families, and the community. I have so many memories of my nearly 11 years at Universal Daroff Charter School that have increased my students' self esteem, added stability and love to their worlds, and have made my students want to come to school again. Some of our kids (yes, our kids – my kids), come to us with needs far beyond reading and math. Our hugs provide a soft spot to land, our encouraging words feed their souls, and when I get called "Mom", by accident, I know I'm doing something right. We've worked so incredibly hard at Daroff to create that safe space. The space where our kids come every day to get everything they need – everything – from breakfast and lunch and education to inspiration and love. We've worked HARD. It's not a simple task to have children trust you after being in a school with a high turnover, a school that failed them, a school they didn't feel safe in. We changed that. We've given our students adults they can

count on, something to be excited about every day, a place where they feel they can succeed, and all of the wonderful childhood memories they deserve.

Our love, hard work, creativity, passion, and tears have created something special – something that wasn't there before – something that our community craved – we're not letting that be taken away from them. My kids deserve more than the disarray we inherited from the School District of Philadelphia.

In closing, I again ask that you do not support the School District of Philadelphia's Hearing Officer's recommendation not to renew Universal's operating charter. You don't break up family.


We ask as the School Board to reject the charter school's recommendation to not renew Daroff, and instead let us have our warm and loving family environment here at Daroff continue.

Good Morning,

I am sending this email asking you to vote against the hearing officer's recommendation to non-renew Universal Daroff Charter School on April 22nd. Below is a short letter of why the school should remain open through my eyes.

I am the Health and PE Teacher at Universal Daroff Charter School and this is my 5th year at Daroff. I have found the Philadelphia School District's decision to not renew Daroff's charter to be very disturbing due to several factors. Not only does the school out perform some of the district schools academically but we also have multiple successful programs that help the community and the scholars, specifically our sports program. Daroff is not just a community school, but a family school. I am in full support of Daroff to continue to be ran by Universal Companies.

Outside of all of the great things Universal Daroff provides to families of the scholars such as having a safe space for families to come and receive clothing, food, and basic household goods. Daroff also provides services such as counseling, health services for both children and adults, adult education classes, parenting classes and our Family and Community Center helps provide services in the city that are normally difficult to navigate such as housing, transportation, and health services. The thing that I will specifically speak about is out sports program. Although we only compete interscholastically in just two sports of track and basketball, I also run an intramural sports

program after school. The sports program is part of the 21st Century afterschool program that offers education, clubs, and even dinner up until 6:00 pm. These programs are helping the scholars stay busy and prevent them from getting into trouble and off of the streets. The after school program is for every grade K-8, but, the sports program is for just 5th through 8th grade. I started the sports program during the 2017/18 school year and we participated in

Is for just 5th through 8th grade. I started the sports program during the 201//18 school year and we participated in a limited amount of sports and still had 76 participants. The following school year we also had 76 participants throughout the 4 grade bands. This past year, 2019/2020, we had a total number of 79 participants and that was only for 75% of the school year. If it was not for COVID-19, with the remaining sports on the list, I anticipate that we would of had about 100 participants to compete in our sports program. I only expect this number to grow as the years continue. We do not just participate in your basic sports, we introduce new sports to the scholars that they may have never heard of or played before. The sports that we have done thus far are flag football, soccer, basketball, track and field, bowling, Ping-Pong, floor hockey, and various basketball competitions (skills challenge, 2-ball, 3v3, 300). I hope to also add more sports to the program as we continue to grow. With all of these sports, I keep track of statistics where we will name Champions and/or MVP's, and a total Athletic MVP. So the scholars are also engaging in some healthy competition. At the end of the year the Champions and MVP's are spotlighted in front of the entire school during a rally where medals and trophies are handed out. I would really hate to see the school not be renewed and have so many scholars out of extra-curricular activities that are so beneficial for these scholars as it truly helps them academically and behaviorally.

I highly recommend the school board, state representatives, and state senator to reject the Charter Schools Office to NON-renew Daroff's Charter and instead renew it for another 5 years, should be more than that even. Renewing is only going to benefit the school, the scholars, and the community. This school is so great that for the past 5 years, I

have been travelling 75 miles one way to come teach at Daroff. If that is not saying something about how good the school, I don't know what will.

My name is Courtney Zelena, and I have been teaching for thirteen years, all of which have been in self-contained special education classrooms. I have called Universal Daroff Charter School my home for the last six of those thirteen years. At Daroff, the self-contained classes are kept small so that we are better able to help our students reach their goals and maximize their potential. Our students with exceptionalities have been provided with access to monthly trips inside and outside of the local community to experience things they may not have been able to experience otherwise. My students have been to shopping malls, grocery stores, the Herr's factory, farms, and other places well beyond their local community. In addition to field trips, we take monthly trips to the local library where the scholars have the opportunity to interact with people outside of the school and gain independence as they check out books. These opportunities are only possible because the class sizes are kept small. When I have attended Special Olympic events with schools outside of the Universal network, I have seen classes with the same population as mine that have twenty kids and the same number of staff. I cannot imagine how my kids would get the same amount of attention they receive now in a class that size. If our charter is not renewed. I fear that the scholars I have worked with over the last six years will be placed in larger classes and not get the attention and support they need and deserve. I fear their programs will be discontinued and they will be sent to schools outside of their neighborhood. Please reject the hearing officer's recommendation to non-renew Universal Daroff's operating charter as all of our children deserve the best education possible.

I am extremely proud to serve our students and make sure they are getting the supports and services they need to be and feel successful. Over the years, I have worked in all grades from kindergarten through 8th grade and can say that I have been blessed to be part of their elementary school journey from the beginning up until they graduate as 8th graders. The relationships I have with my students and their families are what I cherish the most.

I'm writing this letter to express my concern that the Philadelphia Charter School Office has recommended nonrenewal for Universal Daroff Charter School, a school that has been such a major part of my life over the past ten years. I AM ASKING YOU TO VOTE AGAINST THE HEARING OFFICER'S RECOMMENDATION TO NON-RENEW UNIVERSAL DAROFF CHARTER SCHOOL.

I was a "change of career" teacher who was looking for a school I could call home. After working as a teacher for several years elsewhere, I joined the Universal team and found the school that I knew was where I belonged and where I could make the most difference.

I am one of the first teachers who joined up to 'turn around" a school that was so badly mismanaged, neglected and abandoned by the Philadelphia School District that they had to give Samual L. Daroff School away to an outside company to give it a fighting chance to survive and educate the students of West Philadelphia. When we first arrived in August of 2010, the school was filthy and in disarray. We pushed up our sleeves and got to work so that when the students came in September, we would be ready to offer them the best education possible. We never looked back!

Over the past ten years, I have taught kindergarten, first and second grades. As a kindergarten teacher, I saw firsthand how the children from the neighborhood come to school without the prerequisite skills needed to be a successful kindergarten student. Students come to us without knowing any letters or their sounds, without being able to recognize their name in print, hold a pencil and a pair of scissors properly, and without being read to enough at home. It takes incredible dedication and patience by the teachers and staff to not only teach these students the prerequisite skills needed but to help them soar. This feat cannot be accomplished without giving your heart and soul to your students; without loving them and pushing them to succeed like you would do to your own children.

We build relationship by loving our students, reaching out to them and their families to assist in many ways - school supplies, food, clothing, medical help, parenting classes, to name a few. We teach the younger siblings, cousins, nieces and nephews of our students and become more and more part of the community and their families. We are invested in these families!

Honestly, over the last ten years, I have seen administrators, teachers and staff come and go. It is not an easy job and it is not for the faint of heart. Over the past four years, our administration team of Dr. Ruffin and Ms. Hollenbach have provided the stability needed to attract excellent teachers and staff. More and more of these teachers and staff are feeling supported enough to stay and continue doing their best for the students and families we serve. The students and families of the community deserve better than having to start over and having the last ten years of hard work being in vain.

Based on the reasons stated above, I am asking the School Board to reject the Charter Schools Office recommendation to non-renew Universal Daroff's School's charter and instead renew its charter for another five years.







Our scholars look up to us, and they look forward into seeing us every day. Closing the school can't be the answer.

We may have failed the renewal, but I can name a million things we succeed in. As a PCA worker at Daroff, I succeed in teaching my scholars how to read, write, be kind to one another, how to respect their peers, and how to be themselves. Our scholars look up to us not only because we teach them every day, but also because they see themselves in us. When they turn on the computer every day, they see role models, and when we look at our scholars every day, we see our future.

The last thing we need is to have our scholars feel like we failed them and failing them would be closing our school. Having our scholars start over at a different school could make them feel uncomfortable and shutting our school down could make them feel unwanted. I don't know anyone who would want to do that to kindergarten, first, and second grade scholars that don't really understand what's going on. We have to look in our scholars' faces and tell them in the next year or two that we won't be here teaching them at Daroff anymore. I have scholars in my classroom that's going through some really tough times. I have one scholar whose parent has stage 4 cancer, and everyday this scholar is on Zoom doing his work at the hospital. There are times where I have to drop off supplies at this scholar's home because his mom can't get out of bed to go get him school supplies. I have another scholar who just recently lost everything because of a fire, and the school came together last year to make sure while they in were in a shelter that they have everything they need so they can be comfortable. These children that we teach everyday are not just kids, these are scholars that when they go through stuff, we as concerned parents and teachers don't sleep at night because we are worrying about them. We are family. We are home away from home.

Closing our school down can't be the answer, making us feel like we failed our scholars as if we haven't been doing our job, and I know for a fact the teachers and staff I work with do their job and more. Not only do our scholars look at us as teachers, but they look at us as their parents, and as a parent I don't want to fail any of my children - not my children at home or my children that are my home away from home.

My name is Ellen Hemingway O'Brien. I am a lifelong resident of West Philadelphia. I am also a teacher at Universal Daroff Charter School. For as long as I can remember, it has been my goal to give back to my community in a meaningful way. It wasn't until I began working at Daroff, that I was to make progress in reaching this goal

My first year teaching, fresh out of graduate school, I began teaching at a turnaround School within the School District of Philadelphia. turnaround schools are meant to remedy the School District's blatant failures; yet the avenues through which they hope to "turn a school around" only perpetuate their countless failures to the most vulnerable of our students. The lack of leadership was felt throughout the school from administrators, teachers and staff, all the way down to our students. There was no accountability, and it showed. Attendance was not consistent, behavioral problems were rampant, and there was no community involvement or engagement. I had 32 kids in a class, no support staff, and the overall morale was very low among staff members. We were all drained. When I was 9 months pregnant, a student threw a rock at me. Because I no longer felt safe in my school, I left. I think about these kids all the time. What happened to them, are they okay, how challenging was it to have lost a principal, coaching staff, and a teacher? Indeed, I felt guilty. I entered into this profession to give back to my community, and it seemed impossible.

I worked for another charter school in Philadelphia, and while I was struck by the vast differences in leadership at this school, I felt like something was missing. I kept yearning for a school that valued the whole student, the mind, body, and soul. I felt that in order to give back in a most meaningful way, I needed to find a school that loved.

When I was offered a job at Daroff, I was thrilled to be within walking distance from my house. At the end of the first day, I knew I was home. Although we are virtual right now, I can already tell the stark difference in leadership at Daroff. The compassion is contagious at the school. The support the staff feels for each other is palpable; praying for one another, offering encouraging words, congratulating each other's accomplishments, and offering unending assistance, are what make Daroff such a great place to work. The support and climate staff make it so that teachers can feel safe to teach. That's the biggest thing for me. I feel safe. I feel safe because I know that there is accountability, and I know that in that accountability there is humanity and love. As a result, this compassion trickles down and the students feel safe and loved and valued. We bring this humanity and compassion to the community, and our families feel safe and loved and valued. I feel safer in my own community knowing that Daroff is open because of the hub of humanity it represents.

Closing Daroff would be detrimental to the community. It would rip the proverbial rug of consistency right out from under the feet of a community that desperately needs it. Having worked at a turnaround school, I know what Daroff would become if the charter were to be revoked. This community has come so far. It has been able to because of the humanity and love that Universal Daroff Charter School represents. Have some compassion. Have some heart and love for our community, and please save Universal Daroff Charter School.

This has been an unprecedented year. In May 2020, I was laid off from my job of eight years. My family and friends shared words of encouragement stating better things were coming my way and everything happens for a reason. In fact, it was true. In August 2020, I began working at Universal Bluford Charter School as an MTSS (Multi-Tiered System of Supports) Coordinator. Today, I could not be happier with my current school and position. I continue to be impressed. In the heart of West Philadelphia, this charter holds extraordinary, dedicated teachers who work tirelessly to support our disadvantaged students academically, behaviorally, socially, and in every way imaginable. There are a multitude of additional, exceptional staff members who also share the responsibility and honor of serving our students. Professional Development began weeks before the first day of school and has not stopped. Literacy is taught holistically. Data is used to drive instruction; differentiation is a priority. Relationships are built. Students are supported, cared for, and thriving. We are making a difference in the community.

As an MTSS Coordinator, I support teachers in analyzing student assessment data to further drive instruction. I assist with forming strategic small groups and planning purposeful instruction. In attending an i-Ready training on understanding and using data, I am happy to report that Bluford was already doing everything that was suggested and much more. Teachers use best practices and see results. Among having a school-wide data tracker, there is progress monitoring forms for Tier 2 and Tier 3 students. Teachers hold data chats with students as they make obtainable learning goals. As students' progress, small groups continue to reflect this. In preparing to write this letter, I thought of several school strengths that I could include. One thing that I admire most and that is unique to Bluford is that there is a 90-minute MTSS block that students participate in daily! 90-mintues! This is unheard of in my previous schools and overwhelmingly necessary for student success. During this time, teachers pull students for targeted Reading and Math instruction. When students are not being pulled, they are working on their individual learning gaps. This is how to close the achievement gap!

As educators, we strive to do what is best for our students. I understand that often that means making changes. Bluford is more than willing to put in the work to serve our students in the best way possible. After all, that is our main goal! Aside from the phenomenal academic routines and structures we have in place, our students need stability and consistency that many are lacking at home. Bluford is a school that students love to attend and a place where teachers love to teach. It is safe, nurturing, as well as, a second home. I kindly urge SDP and BOE to do everything in their power to offer the option of full in-person education for our students in the Fall (as long as it is recommended by the If both remote and in-person options will be offered, **PLEASE offer a system in which families can opt 100% in-person (or 100% remote)** rather than the hybrid model yet and they are excited to go back even for a few weeks. But teachers and parents who have already returned say that the hybrid model puts undue pressures and burdens on everyone, especially teachers who have to address

But teachers and parents who have already returned say that the hybrid model puts undue pressures and burdens on everyone, especially teachers who have to address Given that the CDC has reduced their physical distance requirement to 3ft., that teachers have received vaccines, and that other safety measures have been ensured, v education for those who need it.

Additionally, I would like to ask the SDP to please include students, families, and teachers in the decision-making about the Fall semester. Over the past year, families were given **one single survey** which was subsequently completely ignored. All decisions thereafter happened without input from students and families, and communicated top-down after the fact.

2. Support for AAPI students and families:

Given the rise of anti-Asian racism and hate crimes, I ask SDP and BOE to offer increased and active support and resources for AAPI students and families, to understa find ways for schools, teachers, and families to help.

Good Afternoon,

My name is Pamela Thompson and I have been a certified secondary (7-12) mathematics teacher for approximately 30 years. I joined the Universal Daroff Charter School family in March 2016. I have the opportunity to teach my current 8th grade scholars, math, since they were in 5th grade. This looping opportunity has afforded me the privilege to experience the tremendous growth of my scholars academically.

Looping with my current scholars for four years, I have seen an academic growth mindset. My scholars have acknowledged their failures and created goals to improve themselves. For example, I am a data driven educator. I believe that scholars should know what their weaknesses are and what they can do collectively or individually to improve their scores. So as a whole group, we devised an action plan. This action plan held all three stakeholders, which included: the scholar, parent, and teacher accountable. Each scholar met with me, individually, to look at his/her PSSA scores to determine which skill(s) that they need to improve on.

Through the use of data charts, scholars have been taking more accountable for their schoolwork. Students have made connections between the daily lessons, units, benchmarks and PSSAs. Due to looping over the past few years, students have been able to communicate with each other and myself more effectively. This has created a strong bond between all stakeholders. Parents also became more active in their scholar(s)' progress by joining class dojo and utilizing PowerSchool.

After reviewing each scholar's data with the data coordinator, the instructional math coach and myself, we came up with targeted strategies to improve their overall math scores on school, district benchmark, and state exams. These various strategies included MTSS small groups, computerized math programs to work on target skills, after school tutoring sessions, Saturday School and becoming a more active participant in the classroom. We also targeted high frequency skills, various problem solving strategies, the incorporation of writing

across the curriculum, and small groups. With the commitment of all the three stakeholders, the scholars' PSSA scores have improved.

As a teacher, I took this opportunity to incorporate more accountable talk and became more of the facilitator than a lecturer. My weekly lesson plans were an affirmation on what I must do, as a facilitator, to assist my scholars to reach their goals. I used strategies that address their deficient from previous year's PSSA scores (eMetric reports) but from quarterly district benchmarks, and the Eureka Math Program. My Do Now activities differentiated small groups and scaffold instruction helped address areas of weaknesses.

This will be my last year teaching my scholars, as they will be moving into high school next school year. I have not only seen them grown academically, but as future leaders of tomorrow. They are dedicated to not only holding themselves accountable for their own academic success, but each other. They know what it takes to be responsible and productive students for the 21st Century.

In closing, I again ask that you do not support the School District of Philadelphia Hearing Officer's recommendation to non-renew Universal Daroff Charter School's operating charter.

It was brought to my attention that Daroff Charter School is at risk of closing. I AM ASKING YOU TO VOTE AGAINST THE HEARING OFFICER'S RECOMMENDATION TO NON-RENEW UNIVERSAL DAROFF CHARTER SCHOOL. There are several reasons that the school should remain open to include but not limited to statistical evidence, environmental, social and emotional well being of the students and community and the staff's commitment to the community.

The first piece of statistical evidence that I would like to reference is the fact that Daroff has the 2nd highest rate of enrollment compared to similar schools. I know that it may seem like this is due to location or that another company would get the same results but I would like to say I don't think the school board would get the same results. I believe the enrollment rates are due to the community ties. Community ties that include: hiring community members, hiring a higher number emotional and social well being staff then seen in most public school settings, and caring for the students whole family to include recognition of religious observations, food drives, MTSS period and working with local groups to have reach into the community.

The second statistic I would like to present is that our overall performance compared to similar schools has us ranked and number 10 out of 29 schools. This is yet another statistic I am sure the school board would not be able to produce in this area. Why, you may ask. Unlike other areas in Philadelphia where school have been taken back by the school board and kept similar numbers to that of the charter, the neighborhood around Daroff is NOT being gentrified. To give you a clearer picture McDonalds and Save-A-Lot are in walking distance and Starbucks is not. While I love to bring my morning cup of Starbucks in, I also recognize that my cup of coffee is often discussed and talked about as a status symbol amongst my students and their caregivers. Those comments are something that others and myself as staff members know how to handle. Why is this important to performance? This is important because the staff members are a balance of professionals with degrees coming in from other areas and those who are from the community. We have formed a family environment that engulfs the total student. Staff members at Daroff build a rapport with the community. The staff has called each and every absent scholar during the pandemic, the staff works with parents experiencing socio-economic hardships and the community trust us with their personal issues, knowing their religious affiliations and most of all they trust us with their children. This is what makes our students perform at such a high level as well as what reiterates itself with our enrollment statistics.

Lastly I would like to state the in comparison with similar schools we ranked number 9 of 29 in our overall 3 year performance statistics. This shows that our student's growth is not a phenomenon, this growth is happening gradually and continually. I would also argue that snatching students out of the hands they trust would stunt such growth. The school board taking control of Daroff at this point would be devastating to the community. This devastation can only be compared to taking a child away from it natural parents (environment) at birth, traumatizing the child (such as the school was traumatized when Universal Schools came in), giving the child back to it's natural parents and watching the child flourish just to snatch the child back. Just to make it clear. Universal Charters provides that natural environment that our students and community need to flourish. Taking the students out of this environment just doesn't benefit the students or the community.

In conclusion, I know the staff and environment formed at Daroff cannot be duplicated nor replaced. - **Student growth and achievement:** the latest PVAAS data attests that our school achieved the PA Standard for growth in some grades/subjects; and also shows significant and moderate gains in other grades/subjects;
- Professional qualifications for staff: growth plans for certification and advanced degrees are agreed upon and supported;
- High rate of student and staff attendance: daily attendance rates remain in the high 90s;
- **Compliance of Special Needs and ELL students:** the determination to meet our students' needs has not been diminished in our virtual school;
- Communication with parents and families: meetings, mass phone calls, emails, letters, student handbook, newspaper articles, ClassDojo, and calendars, keep parents abreast of all that is Bluford.
- **19th Police District:** visits our school to participate in fun activities because they like and care for our children and staff, as opposed to being called upon for weapons and drugs, in which there were incidents as such, prior to Universal managing Bluford.

Universal Bluford is an integral part of a vibrant West Philadelphia community. Though, COVID-19 has changed the way some of the community programs happen, the community still benefits by having a stable institution that cares about its surroundings. The school strengthens the community by offering the following programs as well as a host of others:

- Chrome books for virtual learning
- Thanksgiving turkey distribution
- Winter coats distribution
- Providing for the needs of our homeless students
- The Food Pantry program

Universal Bluford is a member of the African-American Charter Schools Coalition. This Coalition operates 19% of the city's charter schools, though the charters of these schools are non-renewed at the alarming rate of 87%. The question I pose to the Charter Schools Offices is: What is the justification for the non-renewal at such a significant rate? Throughout my teaching career in both SDP and charter schools, I have witnessed first-hand the biases towards some institutions, and have worked on teams in which we had to justify ourselves differently. These differences were attributed to racial, financial, and location factors.

Universal Bluford is recognized as a point of neighborhood pride by Pastor Jefferson who is a prominent member of our community at large. Pastor Jefferson has witnessed first-hand the positive contributions and changes that Universal Bluford provides as a neighborhood stronghold that is future bound.

Universal Bluford's strong, caring administration, and loving staff work as a cohesive unit for the betterment of our school family and surrounding community. The solid systems that were paramount during the transition from our physical building to a virtual environment on Friday, March 13, 2020, ensured our students had their lessons, materials, and access to their teachers on the following Monday. Shortly thereafter, the entire staff was trained on Zoom, and chrome books and textbooks were distributed to our students. Within a few weeks, students were in virtual school full day and learning new material. The smooth transition proved successful because our supportive administrators and ambitious staff worked towards a common goal, teaching and taking care of our children. The systems in place are even stronger today because Team Blue doesn't settle for less, we are a non-stoppable force to be reckoned with when our children, our school, and our community is at stake.

It is my opinion that the gains of the solid educational experience provided by Universal Bluford helps to solidify and strengthen all stakeholders. These gains will be greatly diminished and the results will have devastating consequences, if Universal Bluford Charter School's charter is not renewed. Therefore, I am asking you to reject the Hearing Officer's recommendation to non renew Universal's operating charter and grant Universal Bluford Charter School another five-year contract.

Good afternoon. My name is Maureen Skaates, and I am a speech-language pathologist with the Philadelphia school district. I primarily serve students at Grover Washington Middle school, and I assist with the caseload at Anna B Day elementary school.

I am here to ask the district to increase the number of speech language pathologist positions.. I am also advocating for a workload-based model of service delivery for SLPs. The current caseload guidelines promote a "one size fits all" approach, which is not ideal for our diverse caseloads.

I have the privilege of serving students in 7 self-contained special education classrooms. My students have a variety of communication impairments. Some have difficulty producing sounds, and others may struggle to understand them. Some have complex communication needs and require the use of assistive technology to express their thoughts and ideas. Some have a diagnosis of autism or intellectual disability, and they need extra visual support and structure to effectively understand and express language.

If I had a more manageable workload, I would be able to spend more time in our self-contained classrooms, giving me the opportunity to see and hopefully prevent communication breakdown in real-time. I could better train staff how to use assistive technology and communication devices. I would have the time to engage in meaningful collaboration with teachers and other related service providers to ensure each student's needs are met.

I have been an SLP for 17 years. My colleagues in this district are some of the most knowledgeable, creative, passionate professionals I have encountered. Unmanageable workloads result in talented therapists leaving this district. High turnover and the use of expensive independent contractors weakens the bond between students and therapists. This results in slower progress for our students. Please allocate more SLP positions into the budget. With more highly trained professionals available, we will be better able to serve our most vulnerable students. Their voices deserve to be heard.



Board of Education Action Meeting, 4/22/21 Dr. Cheri Micheau, Ph.D., Educational Linguistics Community Member, Retired TESOL (Teachers of English to Speakers of Other Languages) Professor

I would like to comment on Action Item #1, the extension of funding for the William Penn Foundation's program for English Learners entitled "Together is Better." My concern is not with the extension of funding, since with the intervention/interruption of virtual learning since spring of 2020, this program has not been able to be implemented. My concern is, rather, about the program itself.

First, I am concerned about outside entities' setting policy for the SDP in exchange for

funding. I understand that William Penn offered the "Together is Better" grant— implemented in several K-8 schools in the Northeast—with the stipulation that the SDP actually adopt a specific language instructional policy for those affected schools: That ESOL would be delivered through push-in instruction or "co-teaching." In other words, it seems that William Penn is now dictating language policy for the District as a condition for receiving funding. To my knowledge, there are no second language experts at William Penn who are qualified to claim credibly that this model for delivering language instruction is effective, and sadly, when this program was proposed, leadership in the OMCP was also not qualified—or even sufficiently engaged—- to make such decisions.

Second, I am concerned about the research foundation for this instructional model. There is no significant research in the field of second language acquisition and instruction that supports this instructional model AS A LANGUAGE TEACHING MODEL. In fact, it is very difficult to design research to "prove" that a certain instructional model is more or less effective. Variables such as teacher proficiency, classroom climate, linguistic and cultural background of the students, and level of professional training can all affect the quality of instruction through ANY instructional model, and it would therefore not be feasible to compare results across classrooms and instructional models.

However, second language research strongly and unequivocally supports **explicit** language instruction as key to language acquisition. No second language acquisition expert claims that students can simply "pick up" or "absorb" all the necessary features of a second language while

focusing on learning math or science or social studies, for example. Second-language students/English Learners need opportunities to:

- practice reading, writing, vocabulary and structures sufficiently—-repeatedly, over time—so that these linguistic features and skills are retained and so that they develop fluency in using them;
- explore the sounds in English (especially those that are not part of their native language), key for developing phonemic awareness;
- acquire sufficient cultural and academic background knowledge to read and listen competently;
- receive feedback on their oral and written products;
- practice in a supportive setting in which they feel comfortable and not "under the microscope" of native speaker peers;
- focus on language learning without the distraction of also addressing content skills simultaneously.

That ESOL teachers can supply this necessary explicit language instruction "on the fly," in the course of a rapidly proceeding content-area lesson is unrealistic. In push-in classrooms ESOL teachers often end up being nothing more than classroom aides. Of even more concern, students in push-in classrooms, in many cases, are being denied their federally-mandated right to second language instruction. It is an ill-advised use of ESOL teachers' skills and training.

One group that is especially harmed by this program is the group of newcomers who arrive at their schools with zero English. That these students can simply "follow along" in a content lesson with ESOL teachers' limited help, and that teachers can accommodate their content-area lessons for such low-proficiency students seem very unrealistic expectations based on inaccurate assumptions about how language is learned and how language acquisition proceeds. In addition, it is not uncommon for newcomers to have been exposed to very little education in their home countries; we have students arriving in Philadelphia with no literacy skills in any language and no exposure to even very basic math. Can we honestly claim that these students can succeed with such limited support?

To be clear, it is desirable that content-area lessons be adjusted and accommodated to the needs of English Learners at various levels of proficiency. It is also desirable that ESOL lessons be attuned to the linguistic challenges faced by students in content-area lessons. There is no problem with additional adults' assisting English Learners—or other students with specific needs —- during content-area lessons. There is also no problem with content and ESOL teachers' planning together. There is no question that content and ESOL teachers can learn from each other while planning and delivering lessons. But the specific work of providing second language learners with the necessary LANGUAGE practice, explanation, and feedback cannot be done by an ESOL teacher's drifting around the room during science or math or literacy, whispering suggestions into ELs' ears.

Clearly, William Penn's assumptions behind this program—-that content-area and ESOL teachers can work together to plan and deliver lessons, that they can, in the process instruct each other on best practices for teaching their subject matter, and that closely connecting language instruction to the specific challenges and requirements in the "regular" classroom can foster greater competence in academic language—-are all sound. What is missing is, as noted, the provision of **explicit** language instruction. Another model—-the adjunct model—-calls for a co-teaching model for the content lessons, with ESOL and content teacher working together to plan and deliver that lesson, but for an additional linked daily **language** lesson in which English

Learners are given explicit language instruction and practice opportunities on the language needed to successfully process each content lesson. This model has been implemented only rarely in the SDP, for reasons outlined below.

Third and finally, the William Penn Foundation program is limited and not implementable throughout the city. "Together is Better" is offered in only two K-8 schools in the Northeast. Grant funding is provided so that content and ESOL teachers can be released for co-planning time; sufficient, additional staff is provided, so that ESOL and content teachers can co-teach content lessons; professional development is also provided through this funding. Indeed, in order for a co-teaching program to work on any level, there must be time for co-planning and sufficient time for the ESOL and content teachers to deliver lessons together. In most schools, however, there is no opportunity for teachers to co-plan; ESOL teachers across the city are stretched very thin, often supporting multiple classrooms in each grade, thus preventing them from co-teaching where needed. Professional development on all the aspects of co-teaching has not been widely available beyond the two "Together is Better" schools. Yet the OMCP decided that push-in instruction/co-teaching should be the instructional model in certain grades throughout the city. In other words, the policy dictated by William Penn became the policy across the District.

This ill-advised program is yet one more example of the lack of attention to and informed decision making about instruction for English Learners in the School District of Philadelphia. I urge you to invite representatives from OMCP (Office of Multilingual Curriculum and Programs) to present to the Board on EL programs and initiatives, so that you may ensure that the rights and needs of this group of students are not being ignored.

The way students learn today seems worlds apart from how children were taught, even one generation ago. Technology commands the playroom and the classroom, and even preschoolers are adept at using smartphones and tablets. Yet through the ages and despite all of the technological advancements, educators continue to face a timeless and universal dilemma. How to inspire our students to read. At the elementary grade level, an online reading intervention program is an excellent tool for assessing and engaging young readers.

Recent events have proven just how vitally important it is for schools and educators to have immediate access to online learning programs that can provide educational excellence while keeping students focused and engaged. With little to no notice, Teachers and students have had to adapt to an entirely remote classroom setting with 100% of lessons presented digitally. Elementary reading intervention programs have proven to be invaluable tools for the teachers of George W. Childs navigating this relatively uncharted new online classroom scenario.

Reading intervention programs for elementary students are based on a three-tiered model of learning. The Response To Intervention (RTI) program begins with all students in the classroom taking part in the same research-based, teacher-led instruction. Finally, those students who do not respond to Tier 2 instruction will progress to Tier 3 for one-on-one intervention and assistance targeted to address their specific learning needs.

Children in the digital age have literally grown up with a device in hand. From watching cartoons and singing along to videos to playing games and searching for Pokemon©, electronics play a key role in how children are entertained and can be instrumental learning tools as well. The teachers at George W. Childs have been using reading intervention programs to help students engage in online reading and set the course for scholastic and personal success.

My attempted topic for publicly speaking at this April 22nd meeting is Action Item 20 and Action Item 4. However, before I address those topics, I am asking again...don't shut us out. The continued speaker suppression foisted on the public by the Board's change to speaker policy follows a troubling nationwide path. Watching the growing voter suppression and protestor suppression cropping up around the country makes the Board's decision to shut people out even more troubling. Why would you want to alienate the public even further unless your actual goal was simply to be the boss and control the narrative?

Two APPS members attended the most recent "conversation" organized by the Parent and Community Advisory Committee and noted it is a nice venue for just that – a conversation. It in no way equates with the public "business" of the Board. Seeing this message - *Registration for the April 22, 2021 Action Meeting is full. This form is not accepting responses at this time -* is the antithesis of community engagement. Please, recognize the distress this is causing to a community already under stress from so many forces. Rescind the speaker changes!

Action Item 20 - Change Orders. I spoke on this topic last month and it should be noted that once again it is a generic description of changes totaling \$1,259,050 for just this month. That brings the total for 2021 to \$4,285,376. Neither you nor the public knows why these change orders were necessitated nor does anyone know who generated them. It is impossible to monitor whether these orders are in line with industry standards or something to be concerned about. This is another example of a discussion going nowhere.

Action Item 4 – KIPP amendment proposal. This item should be withdrawn until all of the confusion and misinformation around KIPP's addresses, grade configurations, and charter contract dates are consistent across District platforms. The many confusing and inconsistent pieces of the KIPP cohort were spelled out in the APPS letter sent to the Board this week. <u>https://appsphilly.net/the-board-should-withdraw-action-item-4-kipp-amendment-proposal/?</u> preview_id=14303&preview_nonce=7825ad081b&preview=true

I would like to add one more significant concern. There should absolutely be no Charter expansion until all Philadelphia public schools are made whole. The Charter school budget item drain on District finances is no secret. Until this problem is resolved, no expansion requests in any form should be entertained. Not even from a school in the *Model* categories of Achievement, Operation, and Finance – which KIPP is not.

Below, please find an open letter from the FLC community regarding the elimination of one of our special ed positions, which we believe to be in error. I had hoped to sign up to testify at the action meeting, but registration was full. Please include the letter below in the official record for the meeting.

We, the undersigned members of the Franklin Learning Center community, are concerned that what seems to be a miscalculation at the OSS is threatening to displace a crucial, valued member of our school staff, and leave some of our most vulnerable students underserved.

For years, FLC has had two special ed coordinators. These dedicated educators work incredibly hard to ensure our students with IEPs have every support they need to succeed. They push into classes, facilitate accommodations, host tutoring every day, and build deep and lasting relationships with students and their families. They do all of this while managing mountains of paperwork, often putting in long hours outside of the school day to keep the system afloat and ensure our students get every opportunity to do their best.

This is a herculean task for two people, but for reasons unknown, the School District has decided to cut one of FLC's two special ed positions in next year's budget.

Despite our numerous appeals, the rationale for this decision has never been made clear to us. 14 members of the graduating Class of 2021 have IEPs, but 21 members of the incoming freshman class have IEPs, and these numbers don't account for the approximately three to five students with IEPs who typically transfer into FLC from Charter or out-of-district schools. All told, our total IEP numbers will be *increasing* next year to *at least* 59 students, and the district has decided to meet this increased need by cutting one of our two special ed positions. The legal limit for special ed caseload set by the State of Pennsylvania is a maximum of 50 students, meaning the District's current budget will have FLC legally non-compliant for the start of the upcoming school year.

Rather than addressing this issue directly and proactively, the District seems to be intent on erroneously eliminating Ms. Dietrick's position, leaving FLC students undersupported for the first month or more of the school year. This would force Ms. Dietrick to find and apply for a different position, start the school year at a new school with new students, and then force her to decide if she wants to exercise her right of return to come back to FLC during leveling in October (which would leave the students at her potential new school with a lapse in support).

The District's inaction on this issue is ironic given the recently expressed concern for student Social-Emotional Learning. No teacher can be capriciously moved between schools without severe consequences for our communities, but this is most true for a special education teacher, who is a critical line of support for many of our most vulnerable students. This is especially indefensible when the sole impetus for this decision seems to be a miscalculation.

This miscalculation has already done damage, causing an incredibly emotionally difficult time for Ms. Dietrick and her students. Some of those students were moved to write out their messages of support to keep Ms. Dietrick at FLC. Please, read the words of these students and review our numbers to see that we need both of our amazing special ed coordinators. Please, make this right and preserve Ms. Dietrick's position.

Ms. Dietrick has supported me and has helped me with my algebra classes, which I consider to be my

most difficult class. She has motivated me to try harder and ever since, my grades have went up

because her and her support she helps me when I'm confused. She has helped me excel forward. She

is also one of the very few teachers I trust and that I can talk to when I'm confused on work or having

a hard time. It would be a great shame to not see her and for her not to help me for the rest of my time

in FLC saying this I hope u reconsider and let her stay she is honestly one of the best teachers I have

had the pleasure of working with. I truly believe Ms. Dietrick can help me and many other kids

succeed and grow.

Dear Members of the Board of Education,

We are writing to you today as the district's practicing, school-based occupational therapists (OTs), to again ask that the board lend its support in our ongoing fight for adequate OT staffing; by ensuring that this is reflected in the upcoming budget.

The model of occupational therapy utilized in this district is outdated, inefficient, and unjust. There are currently 33 therapists serving the thousands and thousands of students who require specialized services; and while some new therapists have been hired recently; most are replacing contractors, retirees, and therapists who moved out of school-based practice. The number of therapists providing services has remained relatively stagnant for as long as our most senior members can recall. A stagnant number of providers in the face of ever increasing demands means that our ability to provide quality, individualized services has been severely limited, as well.

To say that the same model of occupational therapy that worked in 1991 still works in 2021 is irresponsible. As the Board of Education - it is your duty to ensure that students are educated in an equitable manner. OTs provide therapy to support student access to their curriculum: we modify and adapt materials, build hand and eye skills, help students build the sensory and emotional regulation skills to face their day. Occupational therapists are like the glasses that stand between a student's eyes and their book - if a child does not have the proper tools to access their learning, how can we expect them to achieve?

The number of students requiring OT service and the amount of work related to those services, have increased year after year. Occupational therapists have been advocating for a "workload" model to be written into our upcoming union contract that would create true equity by taking into consideration individualized student needs- but the first step to creating a just model would be to simply **hire more therapists**.

Attached with this letter are graphics outlining the vast disparity between Philadelphia and other comparable districts. As you can see - even other nearby, urban school districts provide a *vastly* better student:therapist ratio; OTs in SDP carry double to triple the number of students as other districts - which in practice means that none of our students get the equitable services they deserve. Additionally, in support of the Boards Goals & Guardrails, we've outlined ways OT can support student achievement in all of these areas.

Finally, there is no way to explain all the benefits of School Occupational Therapy in this letter or 2 minute spoken testimony, so I implore you to reach out to talk to the practicing OTs to schedule time to hear about the services we provide to our students and communities first hand. You will find therapists' contact info along with this email.

A Comparison: The Occupational Therapist Student Caseload

Philadelphia School District 1 occupational therapist can hold a caseload of 65-85 students.

Baltimore City OT caseload 35-45 students

Baltimore County OT caseload 35-40 students

Prince George's County OT caseload 35-45 students

Camden City Schools OT caseload 30-40 students *****************

Occupational therapists in the Philadelphia School District can see nearly **189%** more students compared to OTs in other districts.

Reading & Math Goal OT Can:

- Help students build fine motor, visual-motor, & sensory processing skills to: hold a pencil, write letters and numbers, turn pages of a book, align math problems, use manipulatives, etc. -OTs are specialists in motor skills
- Build a sensory routine to foster attention to instruction through multi-sensory classroom activities and learning experiences *OTs are specialists in sensory processing skills*
- Identify & support students who require accommodations to succeed with state ELA & Math work & assessments - OTs are specialists in accommodations, modifications, and assistive technology

College & Career Goal OT Can:

- Help students with disabilities explore postsecondary programs, supports, and accommodations as part of their transition plan -OTs are a critical member of a transition team
- Develop a program tailored to student's individual strengths and skills; adapt tasks, incorporate technology, and modify the environment to enable participation *OTs are highly skilled task analyzers*
- Work with teams to address & build the physical, cognitive, and psychosocial skills needed for post-high school success

Welcoming & Supportive Schools Guardrail OT Can:

- Adapt environments to ensure access and inclusion for all students, regardless of disability.
- Work with schools to create sensory-friendly learning environments
- Fulfill mental health practitioner roles and promote mental health at the district, school, and individual student levels

Enriching & Well-Rounded School Experiences Guardrail OT Can:

- Ensure inclusion of students with disabilities in co-curricular opportunities - OTs are experts in promoting meaningful experiences
- Support students in identifying and accessing extracurricular programs that align with their strengths and interests

Partnering with Parents/Family Members Guardrail OT Can:

- Collaborate with parents and caregivers on strategies to facilitate carryover of skills learned at school, especially those related to movement, feeding, dressing skills - OTs are specialists in activities of daily living
- Ensure families can participate in developing and addressing meaningful student goals

Addressing Racist Practices Guardrail OT Can:

- Provide appropriate OT services to all students who are eligible and demonstrate the need for these services - OTs provide a federally mandated service that ALL students, regardless of race, should have access to
- Provide OT services at a frequency/intensity that is based on evidence and that is sufficient to meet the student's educational needs (not based on staffing/therapist availability)
- Complete work within specified timeframes as defined by the law to ensure timely access to services for all students

THE CASE FOR ADEQUATE OT STAFFING

Occupational therapists have a broad scope of practice that allows us to support all of the Board's Goals & Guardrails. However, with inadequate staffing, our role has been limited to addressing only the most basic student needs, for the most severely impacted students only.
