Dr. Hite & the Philadelphia School Board -

I think we all agree that we want what is safe and best for our students and staff. Mandating students and staff to recieve the COVID vaccine on the heels of the FDA's approval is a crime. Title VII of the Civil Rights Act of 1964 confirms religious rights of US Citizens. In shutting down schools and decimating the social lives of children, policymakers rashly abandon this sound principle, instead thrusting children into known, scientifically proven harm. It is well documented that social health directly impacts mental and physical health, and a traumatic disruption of social constructs – school, sports, church, family gatherings – has devastating effects, especially on children and teens. Our youth were already suffering epidemic levels of depression, anxiety, addiction, eating disorders, and suicide, yet policymakers, such as yourselves, chose to exacerbate this devastation on children's mental health – even when there was no evidence that returning to normal would pose a risk to them or anyone else.

And even as all evidence continued, and to this day, shows Covid-19 to pose nearly zero harm to children, those charged with protecting our children chose harmful and abusive policies. This must stop immediately.

Your abandonment of the precautionary principle with regard to our children's health has caused catastrophic consequences that will span generations.

The definition of abuse is "A non-accidental action which causes or creates substantial risk of physical or emotional

injury to a child." Your policies fit this definition. You have violated social, ethical, and professional contracts to keep our children safe, and instead used your position to knowingly cast children directly into harm using the classic abuse tactics of psychological manipulation and emotional blackmail.

To Whom It May Concern:

I am strongly against receiving the COVID Vaccine. Below is a list of reasons why it would not impede mission readiness, nor disrupt my physical capacity to perform, if I do not receive a COVID Vaccine.

1. The Low Mortality Rate of the Disease

The particularly low mortality rate of the disease, but also its distribution by age, clearly denote that vaccination, whenever it becomes feasible, must be targeted. This percentage is fictitiously over-evaluated for the time being (\sim 2.5%) : on the one hand, due to the over-representation of severely positive cases of the virus [1], and on the other, given that the death toll from COVID has also included the deaths of cases found positive for COVID but with other, underlying diseases (not the SARS respiratory syndrome). The Center for Disease Control (CDC) admits this, saying only 5% of deaths involving COVID-19 had COVID as the exclusive cause of death [2].Recent studies which have estimated the number of deaths in relation to the actual number of people exposed to the virus – based on serological tests (antibody tests) in a specific geographical area – have determined that this percentage is of the order of magnitude of seasonal flu (certainly <1%) [3] The fact of the matter is that COVID has a 99.74% survivability rate, so saith the CDC [20].

2. COVID Mainly Affects People in the Third and Fourth Age Groups

COVID mainly affects people in the third and fourth age groups, where the phenomenon of immune senescence [4] occurs – that is, the reduction in size, quality and duration of their immune response-protection - which can occur, after being vaccinated. In other words, the vaccine- induced active immunity may not be capable of protecting the elderly, who are the par excellence "target" of the corona virus; hence, the finding of an anti-viral therapy should be a priority – assuming that the protection of the elderly is in fact what is desired. The youth are affected very marginally, almost not at all.

3. Asymptomatic Transmissions of COVID are too Insignificant to Warrant the Mandate of a Vaccine

Researchers at Nature Communications [5] and the Journal of the American Medical Association [6] both found that asymptomatic transmissions of Coronavirus are less than one percent. In the case of JAMA, 0.7% of transmissions were among households, which would undoubtedly be lower in the general population or,

hypothetically, a short time in a workplace where we are already spread apart, or an even shorter time in close proximity due to the infrequency or nature of such gatherings. Previously I spoke about deaths due to the virus, but it is probably even less likely that I would spread it to another person, if I had it, than the likelihood that I would die from it. The vaccine's main purpose is to prevent the spread of the disease to others, but that is already incredibly unlikely, not only due to natural herd immunity, but also because, at this point in time, most people who have desired the vaccine have received it, making any mandate of it among those who do not want it frivolous.

4. Among the Seriously III, the Vaccine May Actually Cause More Harm Than Good

With seriously ill patients, acute respiratory failure occurs through an immuno-pathological mechanism (a "storm" producing inflammatory cytokines and reducing CD4 and CD8 T-mediated immune response [7]). There are serious concerns that vaccination will exacerbate this immune complication in the event of a subsequent viral infection and will consequently worsen the patient's clinical course. A similar effect was observed with the FeCoV coronavirus vaccine, which affects cats and causes peritonitis. [8].

5. In the 12-29 Age Group, there has been a notable risk of heart inflammation due to the COVID Vaccine [9]

The CDC reports that there have been many reports of myocarditis and pericarditis following the reception in mRNA vaccine recipients. These are inflammation of certain heart muscles, the myocardium and the pericardium respectively. The vaccine has caused multitudes of people who are not allergic to any product in them to suffer heart inflammation. Many have even died. Therefore, the COVID Vaccine is not only a spiritual threat, as indicated in the prior documents, but also a physical threat. It seems to me very impractical, inconsiderate, and even abusive to mandate a vaccine that has such a high rate of physical harm to a recipient.

6. The Vaccine is Temporary and Will Go Obsolete, Will You Mandate Future Developed Vaccines for Future Mutations of COVID?

The logic of eradicating an infectious disease through global vaccination, on the one hand presupposes the existence of a very safe and very effective vaccine, and on the other hand, most importantly that there be no other hosts of the virus in the natural environment. That is, man

has to be the only species that can host the virus. This is true of the polio virus, but it does not apply to the coronavirus, because all research suggests that the virus originated from bats. Unknown and controversial remains the intermediate link (host?) which had transported it from the bats' caves of Wuhan city. In any case, the disappearance of the virus through global vaccination would only be temporary - in other words, a terrible waste of resources, inasmuch as it could transfer from its natural refuge (the bats or the intermediate host) to the human population at any given moment, capably mutated for bypassing the existing herd immunity and initiating a new pandemic.

Coronaviruses, being RNA viruses, mutate rapidly, gaining genetic and therefore antigenic diversity. This diversity, especially for coronae, also increases through RNA recombination, due to the particularly inconsistent mode of transcription of viral RNAs. Two types have already been identified for SARS-Cov2, S and L [10][11]. It is doubtful that a vaccine can provide both equal coverage for all strains of the virus that emerge, as well as permanent protection over time, hence underlining one more time the importance and priority of finding anti-viral drugs against coronavirus. It is quite likely, therefore, that over time, a global vaccination evolve into regular global vaccinations. Could this perhaps be the aim? Perhaps the corona is the long-awaited pretext for launching the universal transition to a hybrid human biology, where the human body will be protected, strengthened and ultimately dependent on platform technologies (genetic engineering, digital interfacing) through regular vaccinations-updates. But why all the rush for a vaccine that not only does not promise much, but is the cause for concern in the scientific community, especially if it is produced in a hurry and implemented en masse? Finally, do the pharmaceutical industries serve man, or does the opposite apply?

7. Multiple, Eminent Health Authorities From All Across the World Have Warned Against the Safety and Efficacy of Coronavirus Vaccines

Dr. Peter Hotez [12], UK scientist Hilda Bastian [13], and former Vice President of vaccine-manufacturer, Pfizer, Dr. Michael Yeadon [14] have all warned against the safety of the COVID Vaccines due to the nature of their creation. Vaccine development usually takes many years or decades,

whereas the coronavirus vaccine has been manufactured in

less than 12 months. I am not comfortable with receiving a "fast-tracked" product, as by definition, fast-tracking a product means there is no data on long-term safety.

8. Current Pfizer CEO Unable to Say if Vaccine Will Mitigate COVID Transmission [15]

Albert Bourla, CEO of Pfizer, was unable to confirm if any of effectiveness of the COVID Vaccine. It is evident from the above that the vaccine has a negligible effectiveness and a great chance of harm caused to a recipient of the Vaccine. The Vaccine certainly has greater risks than it does benefits.

9. Adverse Reactions and Death Caused by the Vaccines are Underreported

According to a study done by Harvard [16], at the commission of the United States Government, less than 1% of all adverse reactions to vaccines are actually submitted to the National Vaccine Adverse Events Reports System (VAERS). These problems have yet to be fixed.

It is unpredictable what negative effects will be suffered from the reception of the vaccine, therefore I find that it would be inappropriate to mandate the vaccine and, in fact, harmful.

Much of this has been derived from arguments presented by Monk Paul of the Holy Mountain, Biologist, MD Molecular Biology and Biomedicine [17], Christian Elliot's article listing many reasons why to be skeptical of the Vaccine [18], and an anonymous hospital worker's letter requesting an exemption from the Vaccine [19].

I believe that this is sufficient evidence to conclude that it would not be against the best interests, nor would it be a threat to the health and safety, of the environment, workplace, or my compatriots for me to not receive the COVID Vaccine.

Living in a community with a low vaccination rate, I enthusiastically jumped at the opportunity to express my disdain for entities that wish to tell others how they should act, think and behave. While none of us expected the Coronavirus to hit us globally, striving to return to a "normal" life is beginning to cause division and separation based on who is or is not vaccinated.

Aside from all of the conspiracy theories, the decision to become vaccinated is a personal one. Be reminded that egregious acts perpetuated by the federal government on unsuspecting Black men during the Tuskegee Syphilis Study, may cause trauma for some deciding to get vaccinated.

As of August 21st, 51% of Americans have been fully vaccinated yet, in Pennsylvania the number is 68%.¹ When watching the news, the tactic seems to be to blame the unvaccinated and then frighten them into getting the vaccine. 64% of Philadelphia's adults over 18 have been fully vaccinated² and according to Dr. Hite, the vaccination rate amongst teachers is a bit higher. If the district is going to require all adults to be tested weekly (whether vaccinated or not), test children with strong symptoms and require everyone to wear a mask all day AND follow mitigation protocols...**mandatory** mask wearing for all at all times while in common areas or in contact with others on school property, regularly (every 30 minutes) cleaning commonly used areas (including door handles and bathrooms), hand washing and air purification in each learning space; I do not feel that a mandate to vaccine should be imposed. How will those with medical or religious reasons for not getting the vaccine, be accommodated?

Let's not be in a rush to use a vaccination status to be divisive, separatist and elitist in Philadelphia. Instead, let's find alternative ways to keep everyone safe and healthy. For example,

• Work with Philadelphia Department of Public Health (PDPH) to offer vaccination town hall meetings for parents, students and community members in zip codes with low vaccination rates. Many who have not gotten the vaccine need more information about its benefits and easy access to the vaccine after receiving the information. Ask, "Why haven't you been vaccinated?" and offer weekly testing for parents, family and community members.

- Use Family Engagement Liaisons and others already in schools or regularly assigned to visit schools (hire staff) to ensure that mitigation protocols are developed and continuously enforced with fidelity. Some people may have a tendency to get lazy as we move further into the school year.
- Use federal funding to place plastic barriers at each desk and table in each school.
- Create or find a child-friendly video/message that explains how children can help keep themselves and others COVID-free and play it daily for the first two weeks and weekly, as needed, to remind younger students about their role in keeping everyone safe. This can be done during town hall meetings with PDPH, also.
- Have each school host monthly, COVID meetings (virtually and/or in person) with parents, families and community members to update them on how well the mitigation plans are working, the percentage of people in the school who are vaccinated and whether anyone has been infected. This will dispel any rumors and can also give PDPH an opportunity to vaccinate the unvaccinated and educate the uneducated.

Should a vaccine mandate be imposed for all district staff and vendors, what will be the consequence for those who refuse to comply? Be reminded that no vaccine is 100% effective and even those who are vaccinated have contacted and spread the virus.

Good evening,

As the parent of a 6th grader and 3rd grader in the district who are still too young to be vaccinated, I am writing to plead with you to pass a vaccine mandate for all school employees. I have many worries about my kids returning to school in the face of the delta surge--sitting in a classroom every day with 30 other unvaccinated children, eating indoors in large groups--these are things I wouldn't even do right now as a vaccinated adult! Some of it is unavoidable if our kids are going to return to school (and I have my doubts about that, too.) But the one thing I shouldn't have to worry about is the people employed to care for my children making them sick. School employees are tasked with caring for some of the most vulnerable members of our society-- our children under 12, who right now are the ONLY group who can not get a vaccine to protect themselves.

According to the CDC, "COVID-19 vaccination among all eligible students as well as teachers, staff, and household members is *the most critical strategy to help schools safely resume full operations*." The adults in our household are vaccinated and we do not allow our kids to spend time indoors with *any* unvaccinated adults--*not even family members*. So I am definitely not ok with them spending 7 hours each day with unvaccinated teachers and staff. Families have sacrificed a lot for the last 18 months to keep our kids safe and healthy, and we need all of the adults around them to be just as committed to keeping them healthy.

When my younger daughter did hybrid school in the spring with just a tiny fraction of students in the building, there were 6 positive cases at her school, and all but one of them were unvaccinated staff. That was bad then, but unacceptable now. With the more transmissible delta variant, case numbers climbing past what they were in the spring, and classrooms and school buildings full to the brim once again, it should no longer be an option for staff members to put our children at risk by refusing to get vaccinated. Now that the Pfizer vaccine has full FDA approval (hooray!) there are no more excuses. While there are many factors we can not control, this is one that we absolutely can.

Dear School Board Members for The School District of Philadelphia,

I felt compelled to write this letter to you in regards to your upcoming vote on whether or not to mandate the covid vaccine for teachers or other school employees. I urge you to read my letter and watch the videos I am including with an open mind before you decide to vote on this mandate the school district is suggesting.

By putting my family first, I must object to making the vaccine mandated for all employees of The School District of Philadelphia. I have done a lot of research and received much information from all sides of the vaccine controversy from experts that say they are for the vaccine and from experts in the field that state they are against the vaccine. I am an intelligent person. I am not a conspiracy follower. I read all available information, listen to people giving different points of view, and then I make up my own mind. This vaccine has not been proven safe or effective. Therefore, I am not taking care of my family if I get this vaccine. There is no data on long-term side effects from the vaccine. I cannot take the risk of getting a serious side effect or the risk of my own death resulting from the vaccine and leave my children without me. Employees of this district should be permitted to decide for themselves what the best health decisions are for themselves and their family. Our professional community at The School District of Philadelphia should not be taking a stance one way or the other. They should be allowing all members of our community whether

they are teachers, administration, staff, students, and their parents to decide for themselves which medical information they wish to follow to make their own health decisions. I urge you to vote NO to any vaccine mandate.

Regarding the teacher union's position: AFT President Randi Weingarten has endorsed either vaccination OR weekly coronavirus testing. The statements of the union leaders do not always represent what those paying their union dues believe, which is unfair representation. With that statement alone though, by Weingarten, I and many other teachers feel that this vote for a vaccine mandate should not even be taking place. The School District of Philadelphia has already stated that safety measures that will be in place for the new school year are: proper ventilation, consistent cleaning, everyone wearing a mask, and weekly testing for all staff. If all staff are already being required to submit to a weekly test than by Randi Weingarten's own statement teachers should not be forced to get a vaccine/shot that they do not wish to get. Additionally, PFT President Jerry Jordan was asked last spring by teachers during several zoom union meetings if the union would be endorsing vaccine mandates and each time the question was asked Mr. Jordan repeatedly stated that no, he did not believe in a mandate nor would he endorse a mandate for union members because although he himself believed in the vaccine he believed in teacher's rights to make their own healthcare decisions. Now he is saying the opposite to the media but says he would want religious or medical exemptions. What about those teachers/staff members who can't get a religious or medical exemption approved but don't believe getting the shot is in their best interest, for whatever their specific reason is? I hope the union will support all teachers having the freedom to make their own medical decisions. I am asking you, members of the school board, to protect worker's rights and not put teacher's livelihood at risk by mandating a controversial shot that many do not want.

Some people voluntarily get this covid vaccine/shot because they believe the doctors, media, government, and health agencies who state that it was safe and effective protection against covid-19. However, some people who have chosen to not get this shot are using their own judgment and risk analysis of their own health. They have researched information about this covid shot and are choosing to err on the side of caution. They are deciding to listen to information presented from other experienced and renowned doctors and scientists who advise that the vaccine is not as effective as others are stating and may not be as safe. In fact the vaccine can cause serious harm or death. These experienced and renowned doctors give scientific facts and evidence to support what they are saying. Complications can arise from getting this shot. Some side effects include blood clots, myocarditis, autoimmune issues, neurological issues, and many others, including death. These side effects were actually included in an FDA slide presentation. If individuals want to take the risk of any side effects that is their right and their choice. I understand that there are people in high positions of power stating that the vaccine is safe, effective, and necessary but there are also other very intelligent professionals in the medical and science fields who believe the opposite and have given scientific facts to support their statements.

If the CDC, the FDA, and the White House fully believe in the covid vaccine and it's efficacy and safety then they would stand behind it by being accountable should anyone suffer adverse effects in the short or long-term. Instead when you get the shot you are signing a waiver that you understand that there could be possible side effects ranging from a sore arm to death. effects or not getting the shot. There is no data on long-term side effects. Most vaccines take 4 years of trials to determine the overall effects and whether it is safe for your long-term health. We do not have 4 years of data for this vaccine. The CDC website admits that there is no long term data for adverse side effects. We do know that people who are vaccinated can still catch and spread the virus. Since it is not effective at stopping the virus, how can it be mandated? Why are effective medications being suppressed instead of being widely discussed? India refused the vaccines and had a huge outbreak of the Delta variant. They provided Ivermectin, zinc, and doxycycline for \$2.65 to all of it's citizens. The covid outbreak immediately abated.

Teachers don't demand that all students and staff be mandated to get the flu vaccine every year. Even though the fu is highly contagious it is nobody's business to dictate to others what kind of medical treatments to get or not get.
