I write today regarding two key issues with regard to COVID-19 in SDP and procedures around quarantine:

First, many are aware, the "quarantine learning" component of the school year has been a tough start for many families. We are consistently hearing that kids are going into quarantine and either have nothing to do, or they are just expected to keep up with the class work with no instruction. Obviously that's challenging enough.

However, we are also hearing consistently that families and the kids themselves do not understand why or how they are being tagged for quarantine! I have not received a notice myself, but we hear that families get semi-vague notifications about being a "close contact" and then that's it, straight into quarantine. We have families, including ones with children in very small cohorts, that are being tagged. This includes some that have already been tagged TWICE. Many kids don't know how, why, or where it was that they met the "definition" of close contact.

Basically these kids are being suspended from school for a week or 10-days. And their families don't really know why, how they can avoid it or what to do differently going forward.

These are kids that do NOT meet the CDC definition of a close contact (since they are masked) yet the PDPH has seen fit to block them from school and learning. More must be done here to improve communication, shift to the CDC definition, and not just ALLOW test to stay, but actually IMPLEMENT it. It has been proven to be the best balance of keeping kids safe but also keeping them learning in schools. Full stop.

Secondly, as part of the quarantine procedures, we are also hearing many stories that student testing centers are not available, not open at their appointed hours, or have multiple hour waits. This just adds to the frustration. These are families, sometimes taking time off their work, trying hard to get their kids back into school, and they are being stymied. It seems that either we need a new vendor, or our current vendor needs to step up. This must be done to help families navigate this process!
