### Board of Education Public Meeting Minutes October 20, 2022

A public meeting of the Board of Education was held in hybrid format on October 20, 2022. Some Board Members, select staff, and some registered speakers participated in-person, while others participated remotely. Members of the general public who did not attend in-person participated via Zoom meeting platform.

The meeting was convened at 4:02 p.m., by Joyce Wilkerson, President. President Wilkerson reported/commented on the following:

- Acknowledgement of the Superintendent's 80 member transition team for their hard work and dedication to improving key areas of the School District and making an invaluable contribution to our new strategic plan.
- Recognition of the City of Philadelphia's Chief Education Officer Otis Hackney for his dedication and commitment to the success of Philadelphia's children as he prepares to step down from his post.

Vice President Egea-Hinton made announcements concerning recording, copyright, participation in, and viewing of the meeting.

Board Member Fix-Lopez provided brief remarks encouraging members of the community to register to vote no later than October 24, 2022, in preparation for the upcoming election on November 8, 2022.

### **Roll Call, Minutes, Announcements**

Lynn Rauch, General Counsel, announced that the Board met in executive session on October 3, to discuss privileged, confidential personnel matters; on October 13, to discuss privileged, confidential, quasi-judicial charter school matters; and on October 20, 2022 to discuss confidential, privileged, personnel, safety and security, labor relations, and quasi-judicial charter school matters, and information or strategy in connection with the following litigation: APPS and UrbEd v. Board of Education, Philadelphia County Court of Common Pleas, No. 210302041 (alleging Sunshine Act violation); Sargent et al. v. The School District of Philadelphia, U.S. District Court for the Eastern District of Pennsylvania, No. 22-cv-1509 (alleging discrimination in the school selection process); and Watson v. The School District of Philadelphia, Philadelphia County Court of Common Pleas, No. 200800222 (alleging claims under exception to the Pennsylvania Tort Claims Act).

Board Member Thompson provided a report from the Parent and Community Advisory Council, including:

- Advisory Council members met on October 13, 2022, to discuss a proposed mission statement for the work of the Parent and Community Advisory Council to guide the work of their service
- Advisory Council member shared feedback on Board Policy 916 - Volunteers
- Recognition that an Advisory Council member was featured on Good Day Philadelphia for the work of their organization, Taller Inc, providing a creative outlet for our scholars in the District
- Recognition of National Disability Employment Awareness
- Recognition of scholars and staff living with Down Syndrome, Dyslexia, ADD/ADHD, Audiology, Sensory Processing, Spina Bifida, World Blindness

Student Board Representative Angelica "Love" Speech reported on her and fellow Student Board Representative Sophia Roach's activities including their participation in a meeting with Mayor Jim Kenney hosted by the Mayor's Office of Youth Engagement on October 19, 2022, to discuss gun violence throughout the City of Philadelphia. Miss Speech shared that during the discussion youth leaders spoke with city officials to share their views on the current climate of gun violence in Philadelphia, organizations that they are a part of, and their solutions to the current problem in our city. Miss Speech noted that those in attendance for the round table discussion focused on four main solutions - unifying the city, youth engagement, access to programming, and mental health. Miss Speech also shared that she and Miss Roach encouraged the Board of Education to vote to approve Action Item 8 - [Contracts with community agencies to support students experiencing homelessness \(\\$3,000,000\)](#), and Action Item 9 - [Contract with The City of Philadelphia's Office of Homeless Services \(OHS\)](#).

At approximately 5:45 p.m. Vice President Egea-Hinton made a motion for the Board of Education to enter into executive session.

The meeting was opened to the public for presentation of statements by registered student speakers and general speakers. Board Member Fix-Lopez provided the applicable provisions of the speakers' policy for the meeting.

The following individuals expressed concerns regarding the current building and environmental conditions throughout District schools:

Lisa Haver, community member, expressed concerns regarding lack of communication and information from the Board regarding charter school renewals and urged the Board to hold renewal hearings for charter schools. Ms. Haver also expressed concerns regarding the Superintendent's Transition Team Report and lack of specific recommendations within the report. Ms. Haver, on behalf of the Alliance for Philadelphia Public Schools, stated an objection under the Pennsylvania Sunshine Act on Item No. 23. First Philadelphia Preparatory Charter School – Application for Charter Renewal, Item No. 24. Tacony Academy Charter School – Application for Charter Renewal, and Item No. 25. The Philadelphia Charter School for the Arts and Sciences at H.R. Edmunds – Application for Charter Renewal.

Mama Gail Clouden, community member, expressed concern regarding the well being of students throughout the District and noted that she came to declare and decree that willful neglect of District students would end.

Horace Clouden, community member, urged the Board of Education and the District to bring back junior high schools for students.

The following community members expressed the importance of all schools having libraries and licensed librarians:

Leah Clouden, community member, spoke about the importance of having licensed building engineers in every school and utilizing resources to encourage student achievement and success, and urged the Board and the District to reopen junior high schools citing the impact that junior high schools have on incoming ninth grade students. Ms. Clouden also demanded that the Board reopen all seven swimming pools across the District, inquired about the head of procurement, and asked about teacher attendance in all schools.

Scott Peterman, community member, reminded the Board of their commitment to discuss changes made to the charter school framework at a public action meeting. Mr. Peterman also shared that his organization, Philadelphia Charters for Excellence, is prepared to work collaboratively with the Board of Education to schedule school visits and discussions.

Mary Beth Morgan, community member, spoke about the importance of transition services for students with disabilities and emphasized the importance of the Mentoring Transitioning Voices program/ curriculum.

Diane Payne, community member, expressed concerns regarding the listening tour as a part of the Superintendent's Transition plan, questioned community engagement as a part of the transition process, and expressed disappointment in the District's decision to refer to stakeholders as customers.

Lynn Landes, community member, spoke about the adverse effects of COVID-19 mandates such as vaccines and masks.

Board Member Streater expressed concerns and a request for some additional legal analysis. Board Member Streater asked if the Board of Education passes a motion to grant a renewal charter, whether that means the school would receive a renewal charter effective July 1, 2022; and if the motion to grant a renewal charter fails, whether that means that the motion does not pass or means that the Board is making a decision to pursue a nonrenewal hearing for the charter school. Lynn Rauch, General Counsel, responded that if five Board members vote yes on the motion, then the Board is passing the motion and granting the renewal charter; that if the motion does not receive five yes votes or receives five no votes, that means that the Board has not granted a renewal charter at this time but it does not constitute a decision to proceed with nonrenewal hearings; and that the Board may consider a vote on a motion to renew this charter at a later time. Board Member Streater asked Ms. Rauch to clarify that the response provided would also apply to Action Item 24 and 25. Ms. Rauch confirmed that the response provided would apply to Action Items 24 and 25.
