

### The School District of Philadelphia

Board of Education Public Meeting Minutes August 17, 2023

A public meeting of the Board of Education was held in hybrid format on August 17, 2023. Some Board Members, select staff, and some registered speakers participated in-person, while others participated remotely. Members of the general public who did not attend in-person participated via Zoom meeting platform.

The meeting was convened at 4:00 p.m., Reginald L. Streater Esquire, President. President Streater

President Streater reported and commented on the following:

- Amended court order earlier this week in the case of UrbEd Inc., and the Alliance for Philadelphia
  Public Schools versus the Board of Education of the School District of Philadelphia highlight new
  guidelines for tonight and in accordance with the administrative procedures for Board Policy 005;
- Announcement that Governor Shapiro signed the state budget which includes historic investments in K-12 public schools to include a \$567 million increase in basic education funding and a \$50 million increase in special education funding:
- Reminder that the start of the 2023 2024 school year will officially begins on September 5th;
- Recognition of the Back-to-School Bus Tour buses, stopping at 11 sites across the City to bring our students and families important information and resources – like backpacks, school supplies and even required immunizations;
- Recognition of Independence Blue Cross Foundation and mega-event co-sponsors that have supported our third annual bus tour which helps families prepare for the upcoming school year:
- Announcement that the District will hold the annual Ring-the-Bell PHL pep rally at Citizens Bank Park on August 28th to officially kick-off of the school year;
- Thank you to fellow Board Members who have taken the time to participate in various events and celebrations this summer;
- Recognition of July and the Charter School's Office attendance at the "All About Love Conference" at Sankofa Freedom Academy Charter School;
- Acknowledgement of the "Signing Day" ceremony, held on Wednesday August 16, 2023 for the FIRST cohort of students enrolled in Parkway West High School's Early Childhood Education CTE program; congratulations to Mikail Grant, Miyon Jones and Shytina Jones for earning your Child Development Associate's Certificate along with college credits and a job offer – right out of high school;
- Announced that the Board will no longer include the "News Business Section" at the end of their meetings
- Announced that the Board will consider Action Items related to our Goals & Guardrails. Vice President Fix-Lopez will be providing a brief presentation later in our meeting.

Vice President Fix-Lopez made announcements concerning recording, copyright, participation in, and viewing of the meeting.

Vice President Fix-Lopez shared brief remarks expressing gratitude to Governor Shapiro and state legislators for passing a state budget. Vice President Fix-Lopez noted that following the court's ruling on fair funding, the Basic Education Funding Commission will be holding a number of hearings across the Commonwealth over the next few months. Finally, Vice President Fix-Lopez also shared that the Board looks forward to welcoming the Basic Education Funding Commission and offering testimony on September 24, 2023.

#### Roll Call, Minutes, Announcements

Lynn Rauch, General Counsel, announced that the Board met in Executive Session on August 3rd and August 10th to discuss confidential, privileged, quasi-judicial charter school matters; and today, August 17th, to discuss privileged, confidential, personnel matters and information or strategy in connection with the following litigation: UrbEd and APPS v. Board of Education Philadelphia County Court of Common Pleas, No. 210302041 (alleging violations of the Pennsylvania Sunshine Act); Sample-Oates vs. The School District of Philadelphia, EEOC Charge #530-2022-0474 and PHRC #2022-12-08-13090 (alleging employment discrimination); Sample-Oates vs. The School District of Philadelphia, Philadelphia County Court of Common Pleas #230401226 (including claims of libel and slander).

### **Committee Reports**

Board Member Thompson provided a report from the Parent and Community Advisory Council, including:

- Advisory Council members participated in our Board of Education Action meeting by providing testimony on Action Items at the June 29, 2023 meeting;
- Provided information on where students not attending summer programs can get breakfast and lunch provided by the City of Philadelphia for the summer;
- providing support to families in preparing for the first day of school and assisting families in receiving back-to-school supplies such as the School District of Philadelphia Back to School Events, Legislative sponsored back-to-school events, back-to-school events our religious partners, and the back-to-school events by our nonprofit partners;
- Provided information and assistance on getting uniforms for the school year for those schools requesting uniforms;

The Advisory Council was provided with information from the School District of Philadelphia staff
on policies including; the origin of policies, the reason for reviewing policies, the cycle when
policies are reviewed, when the Board reviews and finally votes on policies, and soliciting
feedback on policies.

Board Member Sarah-Ashley Andrews shared an update on the selection process for the 2023-2024 Student Board Representatives position. Board Member Andrews shared that members of the Board of Education along with staff have been working to meet with candidates and learn more about their interest in serving as Non Voting Student Board Representatives for the 2023-2024 school year. Board Member Andrews also noted that the Board will appoint the new 2023-2024 Non-Voting Student Board Representatives and alternate at the September 21, 2023 Board of Education meeting.

## **Presentations**

President Streater invited Vice President Fix-Lopez to provide an update on the Board's Goals and Guardrails in connection with Action Item 45 Amendment of Adoption of Board of Education Public Meeting Schedule 2023 - Added 8.3.2023/Updated 8.10.2023 and Action Item 55 - Amendment to the Board's Goals and Guardrails Mission, Vision, and Indicators - Added 08.14.2023. Vice President Fix-Lopez provided an overview of the Board's Goals and Guardrails highlighting the Board's commitment to prioritizing student outcomes and achievement. Vice-President Fix-Lopez shared that in an effort to ensure that Goals and Guardrails remains central to the work of the Board, Action Item 45 proposes an amendment to the Board's current public meeting schedule to include the creation of a Goals and Guardrails committee which will focus solely on progress monitoring and receiving updates on progress being made toward the Board's Goals and Guardrails. Additionally, Vice President Fix-Lopez noted that Action Item 55 provides key updates to the leading indicators to each of the Goals and/or Guardrails with a goal of becoming laser focused on the key strategies and structures currently being used and implemented to help drive student achievement and success.

Vice President Fix-Lopez asked Board Members to hold all questions and comments until the voting section of the agenda.

Ghafurjon Mirzoev, student, spoke about his experience with the school selection process over the past school year and shared that he felt that there was a lack of support from school staff who seemed to have a lack of knowledge in the process.

#### **Superintendent Remarks**

President Streater invited Dr. Watlington to provide remarks. Dr. Watlington reported/commented on the following:

- Recognition of the 350 students who successfully completed summer programming and graduated;
- The Back-to-School Bus Tour;
- Updates on progress toward Year 1 Superintendent's Priorities highlighting key improvements in safety, student attendance, teacher attendance, student dropouts, and 12th grade graduates. Dr. Watlington shared that the data related to academic performance is forthcoming;
- Review of Year 2 Superintendent Priorities and strategies highlighting a focus on accelerating academic achievement and building community partnerships, 37 strategic actions that will begin implementation in FY24;
- Updates on the District's Summer Priorities highlighting a focus on improving the school selection process and successfully reopening schools.

Dr. Watlngton invited Chief Oz Hill, on Ventilation Systems and Energy Efficiency Updates regarding a high level summary of indoor ventilation systems, challenges, indoor air quality, and future plans, challenges and needs.

Chief Hill provided an overview of the District's current Ventilation Systems and Energy Efficiency. Chief Hill shared key information and insight into the District's historical perspective on facility air quality and ventilation, assessment of facility air quality ventilation, Challenges with improving air quality, the District's vision for energy efficiency, energy efficiency challenges as well as Investments that will be needed to mitigate challenges. Board Members engaged in a robust question and answer discussion with Mr. Hill to better understand the current state of the District's Ventilation Systems and the vision set forward for Energy Efficiency.

Following Dr. Watlington's updates, Board Members engaged in a question and answer session to better understand the information presented. Dr. Watlington invited Dr. Jermane Dawson, Deputy Superintendent of Academic Services and Jeremy Grant-Skinner, Deputy Superintendent of Talent, Strategy, and Culture to provide responses to Board Member questions.

#### **Presentations**

President Streater invited Anne Nadol, Commerce Director, City of Philadelphia to provide a presentation related to Action Items 9 - 13 related to the Keystone Opportunity Zone (KOZ). Ms. Nadol provided the Board with an overview of the Keystone Opportunity Zone Program highlighting key benefits of the KOZ program, existing KOZ parcels in the city of Philadelphia, the economic opportunity plan in connection with the KOZ, career connected learning opportunities for students and five (5) potential KOZ projects before the Board of Education for a vote listed under Action items 9 - 13. Board Members asked clarifying questions to better understand the intent behind the proposed projects before them, how the projects will impact the community as well as provide opportunities for students and families. Board Members also asked questions to better understand the process that took place to engage the community before

bringing Action items before the Board. Board Members also expressed concerns related to some of the proposed projects.

A recess was taken at 8:06pm and the meeting resumed at 8:34pm.

#### Presentations (cont'd)

President Streater invited Peng Chao, Acting Chief of Charter Schools to provide a presentation on Action Item 52 - Franklin Towne Charter High School - Notice of Revocation of Charter Added 8.14.2023. Mr. Chao provided an overview of the demographic information for Franklin Towne Charter High School and shared that the Charter School's Office received outreach from Patrick Field, the Chief Academic Officer of Franklin Towne Charter High School alleging concerns regarding unlawful practices as it relates to the schools admission process. Mr. Chao provided an overview of the analysis conducted by Mr. Fields as well as the analysis completed by the Charter School's Office. Mr. Chao shared an overview of the results of the analysis and noted that based upon these results, the Charter Schools Office is recommending that the Board of Education issue a Notice of Revocation to commerce revocation proceedings. Mr. Chao noted that if the Board chooses to issue a Notice of Revocation, that this would mark the beginning of proceedings providing the Board with an opportunity to learn more about what exactly took place through revocation hearings. Following Mr. Chao's presentation, the Board engaged in a discussion and question and answer period on the information presented.

The meeting was opened to the public for presentation of statements by registered students, elected, and general speakers. Ms. Rauch provided the applicable provisions of the speakers' policy for the meeting. Ms. Rauch called general speakers:

Deborah Grill, community member, urged the Board of Education not to renew the charter of Philadelphia Academy Charter School and to vote to approve the Notice of Revocation of Franklin Towne Charter High School.

The following individual spoke in support of Franklin Towne Charter High School and urged the Board of Education to vote no to Action Item 52: Franklin Towne Charter High School – Notice of Revocation of Charter - Added 08.14.23:

Anne Dorn, parent/guardian, spoke about matters related to updates shared during the superintendent's remarks regarding school selection and asked for clarification regarding the process for transitioning middle school students at Masterman to the high school given that the high school has 100 seats available while the middle school currently has 200 seats available. Mrs. Dorn also asked if the district intends to increase the number of available seats at the high school level.

Prabhat Nigam, community member, came to raise concerns regarding Action Item 28 - Contract with Golden Five LLC for Google Workspace for Education Plus Licenses (\$1,214,765.37) - WITHDRAWN BY STAFF 6.28.2023 being withdrawn from the June 29, 2023 Board of Education meeting agenda but noted that he was made aware that the Board would consider Action Item 14 Contract for Google Workspace for Education Plus Licenses (\$1,214,765.37) UPDATED 08.14.23 during today's meeting.

Lisa Haver, APPS, asked for clarification regarding why the Board is voting on only six charter school renewals despite 19 schools in this year's renewal cohort. Ms. Haver also urged the Board of Education to vote no on action items related to the Keystone Opportunity Zone.

llene Poses, community member, expressed concern regarding time to prepare to give remarks related to the Action Items 9 - 13 but shared that the questions asked by Board Members aligned with the questions she had as well. Ms.Poses also noted concerns regarding accountability related to the KOZ and shared that she does not believe many of the areas where the parcels exist to be blighted areas anymore.

Kristin Luebbert, District Staff Member, concerns around the amount of money is spent on consulting contract and importance of investing in the air quality of buildings regardless of the building ages

Barbara Dowdall, APPS, provided remarks regarding the concerns following the graduation at Philadelphia High School for Girls graduation ceremony and asked the District to learn more about the traditions and events that take place at Philadelphia High School for Girls. Ms. Dowdall also highlighted successful women who are alumni of Philadelphia High School for Girls and the rich history that is Philadelphia High School for Girls.

Horace Clouden, PCAC, shared the impact of the Keystone Opportunity Zones on his taxes as a resident. Mr. Clouden also spoke about Action Item 2 highlighting student performance level and teacher attendance. Mr. Clouden also urged the Board of Education to bring back junior high schools. Mr. Clouden also asked Dr. Watlington to test 4th through 12th graders in Math and ELA without a calculator. Mr Clouden also expressed concerns regarding access to aquatic resources.

"Mama" Gail Clouden, community member, thanked the Board and Dr. Watlington for hosting a graduation ceremony for the summer school students. Mama Gail expressed disappointment in the School District of Philadelphia and expressed a lack of trust.

Leah Clouden, community member, thanked Dr. Jonathan Brown and spoke about the importance of providing a summer school graduation. Ms. Clouden also expressed disappointment in the School District of Philadelphia and expressed how residents are not benefiting from contracts as things are outsourced.

Soneyet Muhammad, parent/guardian, shared challenges her family has faced looking to identify suitable and reliable childcare during the summer. Mrs. Muhammad urged the District to coordinate with Out of School Time providers to ensure that child care is being provided when necessary.

Donna Cooper, Children First, urged the Board of Education to vote yes to Franklin Towne Charter High School – Notice of Revocation of Charter - Added 08.14.23.

President Streater shared comments noting that the Board of Education does not take the decision lightly and that any action the Board takes is not the result of the performance of Franklin Towne Charter School; rather, it is about how the school was conducting its lottery. President Streater noted that Charter School Law requires that publicly-funded charter schools that enroll city-wide must use a fair lottery process that allows any student from any corner of the city to apply and have a chance to get into the school.
