Board of Education Public Meeting Minutes January 25, 2024

A public meeting of the Board of Education was held in hybrid format on January 25, 2024. Some Board Members, select staff, and some registered speakers participated in-person, while others participated remotely. Members of the general public who did not attend in-person participated via Zoom meeting platform.

The meeting was convened at 4:00 p.m, Reginald Streater, President.

President Streater reported and commented on the following:

Vice President Fix-Lopez made announcements concerning recording, copyright, participation in, and viewing of the meeting.

President Streater invited Vice President Fix-Lopez to provide additional remarks expressing gratitude for the work of the Basic Education Funding Commission. Vice President Fix-Lopez noted that President Streater testified before the commission in September 2023 asking the legislature to provide resources necessary to ensure every child, regardless of their background, has access to high quality, public education that prepares them for success in the 21st century. Vice President Fix-Lopez acknowledged the release of the commission's report on January 11, 2024 and its listed recommendations.

Julia Elbaum, student, asked the District to please do something to ensure that teachers in school communities are teaching and providing students with information regarding the Israeli–Palestinian conflict from both sides.

Board Members asked clarifying questions to better understand the information presented by Dr. Watlington. Questions included a request for better understanding of the waitlist process as it relates to the school selection process, hiring timeline related to the appointment of a staff person who will support with the monitoring and implementation of strategies related to high school dropout rates, and information related to the District's process for notifying families of school related delays and closures. Board Members also requested additional data related to dropout rates of students living with disabilities and information on strategies that are currently in place to address the dropout rate as the District and Board prepares for the upcoming budget season.

The meeting was opened to the public for presentation of statements by registered students, elected, and general speakers. Ms. Rauch provided the applicable provisions of the speakers' policy for the meeting. Ms. Rauch called general speakers:

The following individuals spoke about the positive impact of Flourish Agenda and Camp Akili and urged the Board to make an investment to expand the reach of Camp Akili to provide more students with a safe space to express themselves, learn about where they come from, the importance of leadership in their community, and the tools to healing from the trauma they experience are children in the City of Philadelphia:

Caroline Tiger, parent/guardian, expressed concern regarding anti-semitism in schools since the event that took place on October 7, 2023. Ms. Tiger asked what will be done by the administration to ensure that school communities are fully equitable and inclusive of Jewish students and their families.

Tashi Grant, parent/guardian, shared her concerns regarding her experience when advocating for her daughter at Henry Lea school. Ms. Grant asked the Board to read the document that she provided and asked that her school be transferred to a Greenfield or an approved private school. Ms. Grant also urged the Board to investigate the principal at Lea School and his treatment of black and brown families of the school.

The following students expressed concerns regarding the lack of sexual education given to students. Additionally these students urged the Board to make it a priority for the District to provide comprehensive sex education and establish a monitoring and compliance process to ensure that students are receiving sex education:

Dawn Chavous, African American Charter School Coalition, spoke in support of Southwest Leadership Academy Charter School, request a moratorium on nonrenewal of charter schools until the Charter School Framework is revamped or dissolved, expressed support for Global Leadership Academy International High School Application, and expressed a desire to work with the Board of Education to reach of a solution to support the students of Mathematics, Civics, and Science Charter School given it's pending closure at the end of the 2023-2024 school year.

Claudia Lyles, African American Charter School Coalition, asked the Board to consider changes to the process for charter schools that would include a request for a moratorium on nonrenewal of charter schools until the Charter School Framework and renewal process is revamped or dissolved and to remove surrender clauses from school charters.

Liz Fitzgerald, parent/guardian, spoke about the importance of school libraries and its impact on student literacy. Ms. Fitzgerald asked the Board to collaborate with students, parents, community members, and advocates to restore school libraries.

Stacey Mandel, parent/guardian, expressed concerns and requested oversight of curriculum related to the Israeli–Palestinian conflict and the need for education professionals to distinguish between their role as citizens and their role as educators to ensure that those teaching our students are not sharing opinions.

Horace Clouden, Parent and Community Advisory Council, spoke about the need to bring back junior high schools and the impact that junior high schools have on students' development.

Thomas Quinn, district staff, spoke about the impact of gun violence and ways that the District can work to help students understand policies in the city that impact. Mr. Quinn spoke about the importance of student voter registration/education and civics curriculum.

Mariyam Walker, community member, spoke about her daughter's experience with the school selection process due to inaccurate issues with her daughter's attendance record.

Tameko Torres, community member, expressed concerns regarding principals who do not feel that students need additional support beyond the school day. Ms. Torres also expressed concerns regarding data being used by the Office of Strategic Partnerships to identify schools who could benefit from the programs that her organization provides to support students and families.

Marvin Reese, community member, shared his experience interacting with school staff and spoke about Team USA's decision to withdraw from after school programs.

Camille Bell, parent/guardian, expressed her support for the need for junior high schools and separation of older children from the younger children.

Charisma Presley, Friends of Philly Aquatics, spoke about the need for real progress which would include honoring the District's core value of equity by making swimming pools and swimming instruction accessible to all students as well as acting with urgency to create after school spaces for students. Mrs. Presley also spoke about the importance of a comprehensive plan that includes collaboration to discuss how all students can have access to resources across the District and the creation of pool catchments.

May Freda Watson, community member, spoke about the importance of reaching the children to help them utilize the talents that God has given them. Mrs. Watson also spoke about the importance of listening to children.

Lisa Haver, APPS, expressed dissatisfaction with the picture of Paul Vallas along the wall of Superintendents outside of the auditorium at 440 N. Broad St. Ms. Haver also expressed concerns regarding Action Item 25 - Approval of Release and Settlement Agreement and Renewal Charter with Southwest Leadership Academy Charter School ("SLACS") - Added 01.22.2024 noting that the Board has a responsibility to share with the community why they have made the decision to reverse their previous decision to non-renew a charter school.

Barbara Dowdall, community member, invited Board Members and encouraged the School District to consider participating in the National African American Read-In.

"Mama" Gail Clouden, community member, spoke in support of Horace Clouden noting that his recommendation regarding the need for junior high schools is based on his experience. Mama Gail questioned why there has not been a serious discussion regarding junior high schools. Mama Gail also expressed concerns regarding the Board's Parent and Community Advisory Council and lack of information that is being shared with the group.

Leah Clouden, community member, thanked the Board for the love and support sent for her father, Horace Clouden. Ms. Clouden spoke about the need for and the importance of junior high schools to give students the tools to navigate their lives.

Board Member Salley asked clarifying questions to better understand the role of the Charter School Office in supporting Charter School Succession Planning as well as expectations related to involvement of a charter school's Board.

Board Member Egea-Hinton asked clarifying questions to better understand what academic improvements have occurred that the Board should consider and what can the Board expect to look different when the school is up for renewal in the Spring of 2027.

Board Member Lam asked questions related to understanding improved practices that would be sustained throughout the renewal term, ways that SLACS has worked to address financial concerns, and mechanisms that will be used to ensure that the conditions listed within the charter agreement are met throughout the renewal process.

Board Member Thompson asked for clarification related to if the parents and families have been made aware of the nineteen conditions that exist within the charter agreement.

President Streater provided brief remarks regarding Action Item 25 - Approval of Release and Settlement Agreement and Renewal Charter with Southwest Leadership Academy Charter School ("SLACS") - Added 01.22.2024 noting that the Board's decision to approve Action item 25 comes back to what is in the best interest of the students at Southwest Leadership Academy. President Streater shared that the terms outlined in the proposed agreement and conditions set forth for the renewal of this charter are meant to address the Board's concerns related to the academic, organizational compliance and financial domain and to set the school up for expected success in the future. President Streatered noted that while he is in support of a 5 year renewal with conditions through June 2027, he does remain concerned about the school's current financial position.

Board Member Andrews shared brief remarks stating that decisions such as this are never easy and stated that the Board's commitment to student achievement must guide their direction. Board Member Andrews noted that while the school has challenges in the areas of governance as well as organizational compliance and finances, the school has made new commitments to rectify the challenges and work with the Charter School's Office to address these issues. Board Member Andrews shared that she looks forward to reviewing the school's Annual Charter Evaluation and seeing the improvements based upon the agreed to conditions.
